"Mt Pleasant works on teaching students about the Zones of Regulation, we work with our Special Ed Techs to teach Social Emotional skills, we are very in tune with our students and we look at our data to refine our ways. We do everything we can to address the most pressing issues. We will continue to address issues as they emerge."


